In March, the Obama Administration announced the creation of its "Blue Ribbon Commission (BRC) on the Future of Nuclear Power in America," to "study and recommend" what the U.S. should do about its radioactive waste problems. So we have decided to hold a National Grassroots Summit and Forum on Radioactive Waste Policy--to articulate a national radioactive waste policy for the 350 million Americans the DOE Panel seems intent on ignoring. The nuclear industry will do everything it can to keep those nuclear provisions intact. We need to counter them with as many voices as possible. We need a lot more people weighing in.
